Selarity is committed to ensuring the safe keeping of any personal information we obtain from you or about you.

Information We Collect

When you complete the credit application, information you provide in writing or verbally will become part of your credit file. Other information to verify your identity such as a driver license, or to verify income such as payroll or tax documents, will also become part of that file. In addition, we intend to use the application to obtain a consumer credit report.

How We Use Information

The information provided by you and any co-applicant, plus the information we receive from the consumer credit report, will be used to evaluate your financial situation for the purpose of securing a loan for you. We do not use the information for any purpose other than to assist you in obtaining financing.

Information We Share

Information you provide to us or give us permission to obtain may be shared with you, any co-applicant, employees of the dealership where you submitted your credit application, and Selarity employees. Lenders that we may share your information with include Bank of America, Bank of the West, Boulevard Bank, Citizens Community Federal, Commerce Bank, Medallion Bank, Merrick Bank and US Bank. We will obtain your permission before we share your information with anyone else.

Information Others May See

In the event the vehicle was financed by the dealer through a national flooring source (such as GE or Textron) or a local flooring source, that lender is entitled to see your complete file if they request it during a periodic inventory audit.

Information We Store

If you execute a loan then all information will be maintained for the term of the loan as required by law. If a loan is not executed, then in many cases the information will be parsed or completely destroyed, usually after a period of time such as 90-days. Certain documents will be retained for a longer period for record keeping purposes or as required by law.
